#### Fayette Fiscal Court Meeting Minutes 6/13/2024

Location: Fayette County Clerk's Office, 162 E. Main Street, Lexington, Ky. 40507 & Remotely Via Zoom Platform Meeting Online, hosted by Fayette County Clerk.

**Present**: County Judge/Executive Mary Diane Hanna, District 1 County Commissioner Brian Miller, District 2 County Commissioner Alayne White, District 3 County Commissioner David Lowe, Meredith Watson (Fayette County Clerk), Doug Burton (LFUCG Div. of Engineering), Mark Feibes (LFUCG Div. of Engineering), Rob Allen (LFUCG Div. of Streets and Roads), Jeff Neal (LFUCG Div. of Traffic Engineering).

1:35 p.m.: Ms. Hanna called the meeting to order and welcomed everyone present.

Ms. Hanna asked if everyone had reviewed the Minutes of the May 16, 2024, meeting. Mr. Lowe made a motion, seconded by Mr. Miller, to approve the Minutes of the May 16, 2024, Fiscal Court meeting. The motion was approved by unanimous vote.

#### **Old Business**

No old business was reviewed.

#### **New Business**

Consideration of County Agreement with LFUCG (FY 2025). Mr. Burton went over the draft County Road Agreement with LFUCG for FY 2025. The projects listed in the agreement are Haley Lane from Briar Hill Road to end (.10 miles), Columbus Lane from Royster Road to end (0.44 miles), Dolan Lane from Leestown Road to Bethel Road (1.25 miles), Mt. Horeb from Iron Works Rd to Join by Lake (0.90 miles), and Royster from Briar Hill Road to Uttinger Ln. (0.90 miles) for a total of \$718,300.00. The total funds accepted are \$812,955.10. He stated that it would be advisable to move the agreement forward to the Urban County Council for action prior to their summer meeting break.

Ms. White asked if unused funds would roll over. Mr. Burton stated that they would.

Ms. White made a motion, seconded by Mr. Miller, to approve the County Agreement with LFUCG for FY 2025. The motion was approved by unanimous vote.

<u>2024 Local Board of Tax Appeals.</u> Ms. Watson gave an update on the Local Board of Tax Appeals membership for 2024. A change in the board members' schedules necessitated a change to the structure. The membership of the Commercial Board will be as follows: Keith Mays (2023 – 2025 appointment Fiscal Court), E. Clark Toleman (2024-2026 appointment Judge-Executive), and Rick Queen (2024 appointment Fiscal Court).

The membership of the temporary Residential Board is as follows: Seth Tuska (2024 appointment Judge-Executive), Kristen LaRue (2024 appointment Mayor), and Ben Campbell (2023-2024 appointment Mayor).

Mr. Miller made a motion, seconded by Ms. White, to approve the membership of the temporary Residential Board for the 2024 Local Board of Tax Appeals. The motion was approved by unanimous vote of the commissioners present.

Ms. White made a motion, seconded by Mr. Miller, to approve amended membership to the 2024 Local Board of Tax Appeals. The motion was approved by majority vote, with Mr. Lowe noting his abstention.

Ms. White made a motion, seconded by Mr. Miller, to approve June 24 – July 5, 2024, as the dates of the hearings for the Local Board of Tax Appeals. The motion was approved by unanimous vote.

Ms. Hanna named Mr. Mays as chair of the Commercial Board, and Mr. Tuska as chair of the Residential Board.

Ms. Hanna noted that April 10, May 8, and June 12, 2025 are the recommended dates for the 2025 Fiscal Court Meetings.

Mr. Miller made a motion, seconded by Mr. Lowe, to approve April 10, May 8, and June 12, 2025 as meeting dates for the Fiscal Court in 2025. The motion was approved by unanimous vote.

There being no further discussion, Ms. Hanna asked for a motion to adjourn.

County Road Agreement FY25 Exhibit Details. Mr. Burton stated the incorrect County Road Agreement FY25 exhibit was included for approval at the 6/13/2024 meeting. Mr. Burton reviewed the correct agreement exhibit which included: Bowman Road from Parkers Mill Road to Old Harrodsburg Road (2.65 miles), Uttinger Lane from Royster Road to end (0.29 miles), Delong Road Shoulders near Keshlyn Kennel (0.23 miles), and Additional Delong Road improvements pending Rural Safety Audit (TBD), for a total of \$858,294.
