## **APPLICATION TO JUNK A VEHICLE TITLE**

WARNING: Only the owner named on this title will be able to reactivate this title in the future. Junking this title will result in a permanent SALVAGE Brand being applied to the title, which may decrease the resale value and cause it to be ineligible for registration in some states. If ever reactivated, this vehicle will be required to go through the rebuilding process, receiving a KY-Assigned VIN, per KRS 186A.090(1)(b), along with a permanent REBUILT Brand, and up to five years of taxes will be due, if owed.

## **ELIGIBILITY REQUIREMENTS:**

A vehicle title must NOT be junked for any of the following reasons:

- Vehicle ownership has been transferred to an insurance company due to receiving payment for a claim. CLERK: DO NOT JUNK THIS TITLE. Customer should transfer ownership to the insurance company.
- Vehicle is damaged and will be sold by the salvage/junk yard for parts or to be rebuilt per KRS 186A.090 CLERK: DO NOT JUNK THIS TITLE. Customer should transfer ownership to the salvage/junk yard.
- Vehicle was sold but not transferred completely, resulting in tax liability
  CLERK: DO NOT JUNK THIS TITLE. Customer should perform an incomplete transfer (CCL).
- Vehicle is still owned by this owner, but is no longer driven.
  CLERK: DO NOT JUNK THIS TITLE. Customer is responsible for taxes on this vehicle until it is no longer in his or her possession.

## Please note, this application should be completed for the following reason only:

$\checkmark$	Vehicle is damaged beyond the resale value. Vehicle will be sold to a junk yard and crushed per KRS 186A.295
	or kept and used for parts only.

CLERK: Customer must have a paper title in hand. Junk this title and provide a registration receipt showing that it is in a junked status.
